

The Impeachment of Obama

U.S. Constitution

Amendment 14 section 3

No person shall be a Senator or Representative in Congress, or elector of President and Vice President, or hold any office, civil or military, or under any state, who having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any state, to have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by vote of two thirds for each House remove liability thereof.

Alaska Constitution
Article 12 s/s 4
Disqualification for Disloyalty

No person who advocates, or who aids or belongs to any party or organization or association which advocates, the overthrow of the government of the United States or of the State shall be able to hold any office of trust or profit under this constitution.

Bill of Rights
Amendment 10

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or the people.

The case for impeachment is as follows:

William Ayers/Barrack Obama Connection
